Pursuant to the Senate Order on Entity Contracts, the following table sets out contracts entered into by the Indigenous Land and Sea Corporation, which provide for a consideration to the value of \$100 000 or more and which:

(1) started during the period, 2) ended during the period, and 3) started before the period and ended after the period.

Some of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- ordinary commercial prudence that requires protection of trade secrets, propriety information and the like, and/or
- protection of other Commonwealth material and personal information.

SS: Statutory Secrecy Provisions	Disclosure would be contrary to statutory secrecy provisions requiring a certain category/categories of information to be kept confidential.
PI: Public Interest	Disclosure would be contrary to the public interest.
TS: Trade Secrets/Intellectual Property	Disclosure would reveal intellectual property or trade secrets that are judged to have the potential to cause detriment to the contractor.
OT: Other	If this code is entered, a free text description of the reason will be provided.
