Purpose of this document

The purpose of this document is to outline the changes to the EOI guidelines distributed on the 2nd April 2024. All changes provided in this document are final and applicants will need to ensure they have read and understood the addendum prior to applying for the EOI.

It should be noted that the below changes will not impact the timelines for the EOI. Applicants will still be required to register their interest by the 12th April at 5pm (AEST) by emailing NCIELtd_EOI@ilsc.gov.au. Following registration, the ILSC will share a copy of the application form which will need to be completed and returned to same email address by Friday the 19th April 5pm (AEST).

The changes

Where the section 2.1 – eligibility criteria previously stated:

If you are an Indigenous company or organisation, be registered under the Office of the Registrar for Indigenous Corporations (ORIC) or demonstrate compliance under the corporations (Aboriginal and Torres Strait Islander) Act (CATSI Act) – see ORIC rule book for further details [Rule book | Office of the Registrar of Indigenous Corporations \(oric.gov.au\)](#);

This has been changed to reflect the following:

*If you are an Indigenous company or organisation registered, **or currently going through the registration process**, under the Office of the Registrar for Indigenous Corporations (ORIC), or demonstrate compliance under the corporations (Aboriginal and Torres Strait Islander) Act (CATSI Act) –see ORIC rule book for further details [Rule book | Office of the Registrar of Indigenous Corporations \(oric.gov.au\)](#);*

Important information

Applicants who are currently going through registration with ORIC will be required to provide proof or confirmation as part of their response. This should be provided as an additional attachment (either a word doc or pdf) and should not exceed 10mb in size.
