## DISASTER RECOVERY QUICK RESPONSE GRANT APPLICATION FORM

The Indigenous Land and Corporation (ILSC) is making grants of up to \$20,000 per entity available through the Disaster Recover Quick Response Grants Program. See the Grant Overview or our website for further information.

### Who is eligible

- An Indigenous corporation (incorporated) may be eligible for assistance if:
  - Its property is within a State or Territory declared natural disaster zone; and
  - It requires immediate assistance to make their property safe to access.

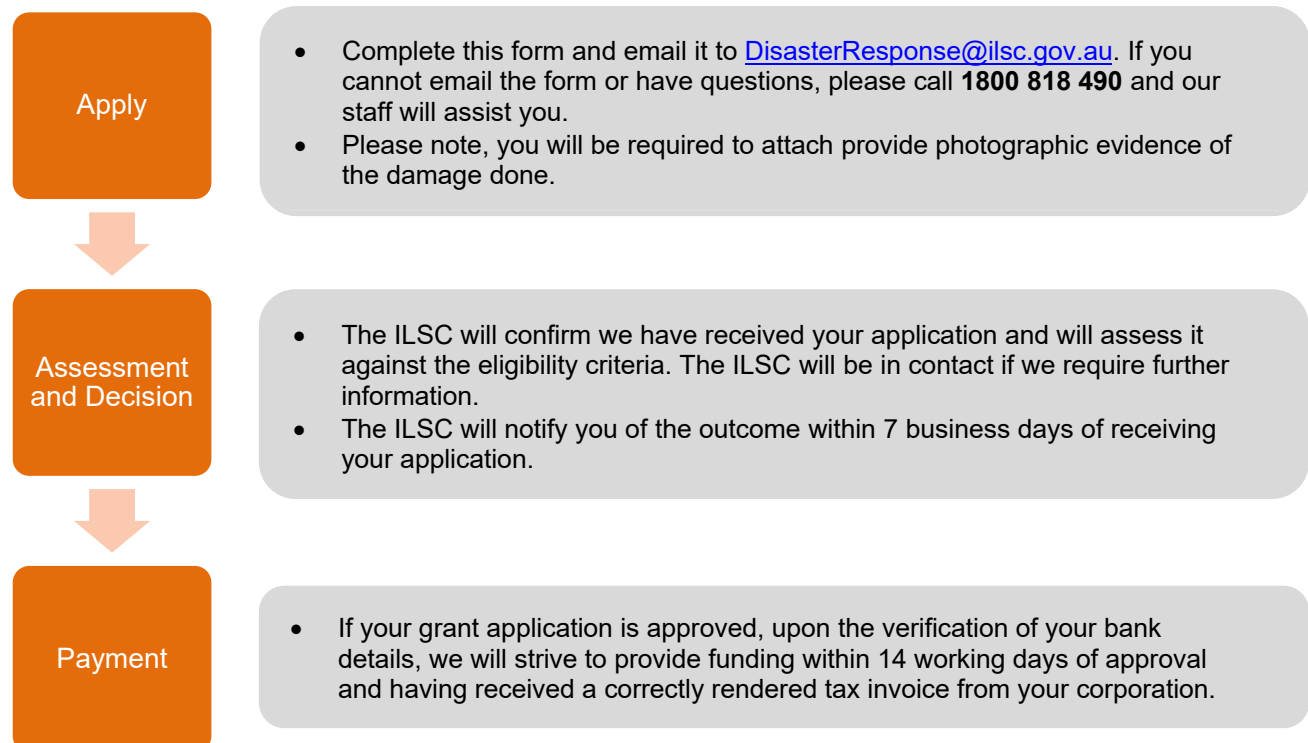
### Funding can be used for

- Immediate clean-up of your property.
- Works to make your property safe.
- Plant and equipment to support the recovery efforts.

### Funding cannot be used for

- Repair and replacement of items that are covered under existing insurance policies unless there is a clear and urgent health and safety risk to humans and livestock.
- Any work that has already occurred.
