The ILC engages consultants on the same basis as it procures all goods and services.

In 2011-12, the ILC contracted consultants for specialist professional services and where the ILC required independent advice, review or evaluation. For example, the ILC acquired the services of consultants to assist with major developments at Mossman Gorge and Western Cape Residential Campus in Queensland, and to assist finalising the purchase of Ayers Rock Resort in the Northern Territory. The selection processes to engage the consultants were select tender and direct sourcing¹.

¹ Selection Process

<u>Open Tender</u> - A procurement process in which a request for tender is published inviting all businesses that satisfy the conditions for participation to submit tenders

<u>Select Tender</u> - A procurement process in which the Corporation selects which potential suppliers are invited to submit tenders

<u>Direct Sourcing</u> - A procurement process in which the Corporation may contact one or more suppliers of its choice in accordance with the Corporations purchasing processes.

<u>Panel</u> - An arrangement under which are number of suppliers are selected through a single procurement and evaluation process
