Indigenous Land Corporation (ILC) is a corporate Commonwealth entity under the PGPA Act established on 1 June 1995 as a component of the national settlement after the Mabo judgment (1992) recognised common law native title rights to land.). Its purposes, as defined in section 191B of the ATSI Act, are:

(a) To assist Aboriginal persons and Torres Strait Islanders to acquire land; and

(b) To assist Aboriginal persons and Torres Strait Islanders to manage Indigenous-held land.

National Centre of Indigenous Excellence Ltd, (a wholly owned subsidiary of the ILC)manages the ILC-developed social enterprise of the same name in Redfern, Sydney, NSW. NCIE Ltd aims to build capability and create opportunity with and for young Indigenous Australians, both from the Sydney community and from across Australia.
