

2019 Calendar Year listing Senate Order Listing of Entity Contracts

Pursuant to the Senate Order on Entity Contracts, the following table sets out contracts entered into by the **Indigenous Land and Sea Corporation (ILSC)**, which provide for a consideration to the value of \$100 000 or more and which:

(1) started during the period, (2) ended during the period, and (3) started before the period and ended after the period.

Some of the contracts listed contain confidentiality provisions of a general nature that are designed to protect the confidential information of the parties that may be obtained or generated in carrying out the contract.

The reasons for including such clauses include:

- ordinary commercial prudence that requires protection of trade secrets, propriety information and the like, and/or
- protection of other Commonwealth material and personal information.

The estimated cost of complying with this Senate Order is \$374. The method used to calculate the cost of complying with the Senate Order is based on estimated staff wages, the number of hours spent on data collection and quality assurance.
